# The Census of the Islands in the British Seas

Saturday 31st March 1901

This Census found the population of Jersey to be 52,576 \* 23,940 males 28,636 females.

As with the previous decennial censuses, there were a large number of professional seafarers away from the island on Census night, altering a more natural balance of male to female. Included in the grand total are 116 sailors and others who were on board vessels in Jersey waters; the military in barracks and forts, with their families - 810 persons, and the 50 crew on board H.M.S. Raven. Of the twelve civil parishes, St. Helier showed the first of the developing ecclesiastical sub-parishes, All Saints, St. Andrew and St. Simon. In some parish enumerator-districts, persons were counted in the Public Institutions of the General Hospital and Union; the Maison St. Marculf private hospital; the St. Helier General Dispensary & Infirmary; the Westmount

Fever Hospital and H.M. Prison.

A letter to the editor of the Jersey Express on the 1901 census day expressed the particular view of one of the Enumerators,

#### Sir

I have had the pleasure this year of acting as enumerator in the taking of the census, and I should like to say a few words on the matter. As yet of course the papers have only been distributed, and have to be collected on Monday. But I was somewhat surprised to find the large number of French people there are here, and in the places we would least expect to find them. Now these people cannot speak or read English. Further, they are not gifted with the highest degree of intelligence, and the result is that they are unable to fathom the mysteries of the census papers. Many have actually never heard of the census before, and gaze in wonderment on the blue paper. They take it mechanically, but I imagine that when the enumerators call on Monday, the papers will be found in the same condition as when left at the house. Had these papers been printed in French the difficulty to a great degree would have been bridged over. The explanations given on the paper are complete, that only the dullest brain could fail to understand them. But given to uneducated people and people who scarcely know a word of English, the difficulty is very great.

I am anticipating no difficulty from the English families in my district, but I do anticipate difficulty with the French people. In many cases the enumerator will have to completely fill the papers, and as the elucidation of facts will take a considerable time, the job is not an enviable one.


It is too late now to suggest that papers be issued with French Instructions, but I think we might have been guided by the difficulties of a decade ago. I suppose though that the same difficulties will exist ten years hence, and that the papers will still be printed entirely in English Yours, etc.

The population of Jersey had continued to grow during the long reign of Queen Victoria 1837-1901 and in January that year, Jersey mourned her death. On January 26, at midday, the Vicomte, Reginald Lemprière climbed onto a temporary dais, wet in the winter rain, to read the

stands behind the Mace Bearer, J.A. Balleine. The party consists of the Bailiff, William H.V. Vernon,
KBE, the Jurats and Crown Officers, Members of the States and members of the Bar. The full garrison of the Devon Regiment, the Foot Companies of the RJA, members of the 3rd (South) Regiment
of the Jersey Militia and blue jackets from HMS Raven formed Guards of Honour on this cold and
wet 26th January 1901. All military Officers had worn mourning (black crepe on the left arm) with
their uniforms from the 23rd January 1901 death of Queen Victoria, until the 3rd March that year.
The Constable of St. Helier gave permission for the Harbour Master to open the Weighbridge
Gardens, where a statue of the Queen had stood since 1890, so the public could place floral tributes.

The beginning of 1901 saw some cold weather with a severe frost on January 5th and three inches of snow fell on January 8th. Gales were recorded on January 19th and 28th and, throughout the rest of the year, gales and fog hampered shipping movements on several days; some journeys taking fifteen hours from Jersey to Southampton. Pipes burst on February 15th and on March 25th severe frost caused damage to the early potato crop. Despite the death of Queen Victoria, some harsh weather and the continuation of the Boer War, life on Jersey continued as normal; although in February, Jersey's Lt. Governor received news of the death of his 28 year old son. Lt. Harry Bertram Abadie with the 11th Hussars at the Anglo-Boer war in South Africa. The Opera House presented plays for most of the year; societies met regularly, a variety of sports events took place; public order arrests

occurred; the States discussed a range of topics; churches held fund-raising events. Some of the more prominent deaths that were recorded in the newspapers;

January 9th Lady Marett of La Haule Manor

February 7th C.P. Perchard of Le Hocq

March 1st Rev. William du Heaume, Rector of Trinity for fifty years, aged 76.

April 25th Dr. J. Thomson

May 21st Mrs. George Phillips at Le Hocq, aged 94

June 29th Dr. J. W. Blampied, aged 42

July 9th John Coutanche, Registrar of Contracts

August 5th B. Newton, aged 86

Sept 20th Miss Julia Westaway, aged 80. J. W. Hosking, aged 82

November 20th Rev. T. Le Neveu, Rector of St. Martin

December 3rd Hubert Browning, aged 74

Incidents of drowning, suicide, accidents and public offence were also noted. Disgraceful riotous scenes occurred in Broad Street, St. Helier on several occasions. Other newsworthy items included:

- The attempted murder (of his wife) and his attempted suicide in King Street, St. Helier in January, Louis Marie Bily was sentenced to two months' hard labour and banished for five years.

Jean Richard, a Frenchman, committed suicide in St. Peter's Valley on 2nd February. On April 20th Mrs. Hutchings and her son together with Robert J. Webb and his family were ordered by the Royal Court to be repatriated for infringement of the Education Law. John Wallace Cabot was found dead in a field and Ernest le Bechec was charged on May 16th, with causing his death and subsequently sentenced to three months' hard labour. On August 24th, Thomas Kelly was sentenced to six months' imprisonment with hard labour for neglecting his family. A verdict of accidental death was recorded October 1st on Reginald Samuel Horman due to the upsetting of a paraffin lamp. Sad to relate was the death, by a fall from Gorey Pier, of the Cook of HMS Raven (District 10, St. Martin) Petty Officer Frank Warrener aged 29 years, two days after being recorded in the Census.



Ladies fashions for the year 1901 were given much prominence and descriptive illustrations like these were common for the weekend's reading in newspapers of 1901.

On the left, "It is really too soon (April) to do without, at any rate, one good cloth frock. The best way is to have a skirt and a coat made to match".

Right, "A grey silk Bolero, this is a bolero of grey taffetas trimmed with a band of black chenille embroidery."



The oldest inhabitant in Jersey on 31st March 1901 was in St. Ouen, Philip Perree's widow, Nancy. She was 97 years old. The youngest to be recorded that day was John and Joanna Drew's third son. Baby William Drew was just one day old.

The Vingtaine called the Vingtaine de Vinchelez with the exception of the Canton de Lecq, bounded on the north by the sea, on the east by the sea and the Vingtaine de Léoville on the west, by the Vingtaine de Millais together with four houses situated on the western part of the Vingtaine de Millais belonging to Francis Le Marquand, John Vibert, Philip Le Gresley and Edward Le Cornu,

# District No. 2. Enumerator: Philip John Le Feuvre.

The Vingtaine called Vingtaine de Millais with the exception of four houses included in District No.1, bounded on the north by the sea, and Vingtaine de Vinchelez on the west, by the sea, on the east by the Vingtaine de Vinchelez and on the south by the Vingtaine de Grantez.

## District No. 3. Enumerator: John Amy.

The Vingtaine called Vingtaine de Grantez bounded by the north by the Vingtaine de Millais, on the south by the Vingtaine called Grande Cueillette, on the east by the Vingtaine de Léoville and on the west by the sea.

# District No. 4. Enumerator: Francis Le Brocq.

The district called the Canton de la Ville au Neveu, being part of the Vingtaine de Léoville with part of the said Vingtaine of Léoville to the south of Trodez main road and two houses belonging to Thomas Ph.
